**CHAPLAIN'S COLUMN**

**THE EXPERIENCE OF THOMAS IN THE EASTER COMMUNITY OF JESUS' FRIENDS**



One of the things that catches our attention in Easter community of Jesus' friends is the difference between the attitude of Jesus and that of his disciple, doubting Thomas called *Didymus*. With a perception that Jesus was a warrior Messiah who would crush the enemies of the Jews and establish a new kingdom, he must have been shocked and disappointed in Him who had become a stumbling block. He refuses to believe that the other disciple had seen

Jesus risen from the dead.

Then, suddenly, Jesus appears to all of the disciples. It is very significant that he tells Thomas to put his finger into his wounds. He wants Thomas to realize how much he suffered. It must be painful and traumatic for Thomas to touch the wound of a friend he had been mourning. Then, when Thomas sees Jesus' wounds with his own eyes, his doubts immediately vanish and he declares Jesus to be his Lord and his God. In his wound offered to Thomas, they shared deep anguish and then joy.

What makes Thomas different from Jesus? The faith of the Risen Christ and love was unconditional. He never thought of: I will remain faithful to God if he continuously blesses my life and keeps me away from trouble. Jesus never thought: I will love others if they are good and kind to me. Rather; he would say, I will love others even if they treat me badly. Prior to his death and rising from the dead, he managed to pray: Father forgive them for they do not know what they are doing. In his appearance as a Risen Lord, his first words he uttered: **Peace be with you!**

On the other hand, Thomas' faith was conditional: *"Unless I see the mark of the nails in his hands and put my finger into the nailmarks and put my hand into his side, I will not believe"* (John 21:25).

The point is, our faith and our love within our hearts must be patterned according to the Heart of the Risen Christ. We love others because God loves us. We forgive others because God forgives us of our sins. Even in our unworthy moments when our hearts are troubled because of sin and division, he offers us his unconditional love with a gift of peace.

In this season of Easter, we pray for this kind of unconditional love. Like Thomas and his friends in the Easter Community, may we experience the joy of the risen Jesus deep in our heart.

**“Medically Necessary” or “Health” Abortions: Abortion on Demand by Another Name**

In the upcoming Senate debate over partial-birth abortions, Congress may try to broaden the scope of the legislation to allow “health” or “medically necessary” abortions. These words are merely terms of art for abortion on demand:

Since the 1973 Supreme Court decisions in *Roe v. Wade* and its companion case, *Doe v. Bolton*, federal law has interpreted “health” abortions to include all abortions performed for the sake of social or emotional “well-being” (*Doe* at 410 U.S. 194).

By longstanding administrative practice, in government health programs such as Medicaid, any abortion performed by a qualified medical professional is by definition, “medically necessary,” no matter what the reason for it. In 1976, 300,000 Medicaid abortions were classified as “medically necessary.”

Defining “medically necessary” in the course of the Hyde Amendment debate in 1978, former Senator Edward Brooke (R-MA) explained:

Through the use of language such as ‘medically necessary,’ the Senate would leave it to the woman and her doctor to decide whether to terminate a pregnancy, and that is what the Supreme Court of these United States has said is the law of the land.... In *Doe* against *Bolton*, the Court defined the words “medically necessary” very broadly; to allow, as the Court stated, “The attending physician the room he needs to make his best medical judgment.”

William Hamilton, vice-president of the Planned Parenthood Federation of America, told *Knight-Ridder Newspapers* that “medically necessary” means “anything a doctor and a woman construe to be in her best interest, whether prenatal care or abortion.” (*The Philadelphia Inquirer*, Sept. 8, 1993).

The National Abortion Rights Action League

(NARAL) has stated that “medically necessary” is a “term which generally includes the broadest range of situations for which a state will fund abortion.” (Who Decides? A Reproductive Rights Issues Manual, NARAL, 1990).

Regarding the classification of “medically necessary,” Senator Bob Packwood, a leading pro-abortion advocate, has correctly noted: “Is there any abortion that couldn’t fit within this definition?”

Four years after California expanded legal abortion to include those for “physical and mental health,” legal abortions skyrocketed from 7,000 per year to 116,749 per year. Over 90% of these abortions were for “mental health.”

## FIELD AGENTS REPORT 2017 Tax Deduction Limits for Traditional Long Term Care Insurance

October 25, 2016 - Los Angeles, CA — The tax deductible limits for traditional long-term care insurance premiums paid in 2017 increased according to a just-released IRS announcement.

“The tax deductibility of premiums when you purchase traditional long-term care insurance provides a real incentive for consumers, especially after retirement,” explains Jesse Slome, director of the American Association for Long-Term Care Insurance (AALTCI). “The special tax advantages are not available when individuals purchase linked-benefit products such as life insurance or annuity policies that can provide a future long-term care benefit.”

According to AALTCI, in 2016 more people will purchase combo products than are purchasing traditional LTC insurance policies. “Only traditional long-term care insurance policies have the benefit of potentially being tax-deductible to an individual,” Slome acknowledges. “After retirement when income typically declines, tax deductions can take on a significant added value to take advantage of.”

Starting in 2017, all individuals may deduct qualified medical expenses that exceed 10 percent of adjusted gross income (AGI) for the year. For 2016, individuals age 65 and older the threshold remains at 7.5 percent of AGI.

Premiums paid for traditional long-term care insurance are includable in the term ‘medical care’. The following are the just announced 2017 limits:

Attained Age Before Close of Taxable Year	2017 Limit	2016 Limit
40 or less	\$410 (+ 5.1%)	\$390
More than 40 but not more than 50	\$770	\$730
More than 50 but not more than 60	\$1,530	\$1,460
More than 60 but not more than 70	\$4,090	\$3,900
More than 70	\$5,110 (+4.9)	\$4,870

### 5 Million Who Itemize Medical Costs Could Deduct Long-Term Care Insurance Premiums

The IRS allows individuals to deduct medical expenses including preventative care, dental and vision care, prescription medications, glasses, contacts and hearing aids. “Many seniors have medical expenses that don’t meet the threshold but when the cost of long-term care insurance is included, the threshold is exceeded providing a significant tax deduction,” Slome notes.

“This is a real benefit for the 23 million individuals age 65 or older who file federal tax returns,” shares Slome. AALTCI analyzed IRS reports for the latest tax

year (2014). “Nearly 5.1 million tax filers who reported income of between \$40,000 and \$100,000 reported medical expenses in excess of the AGI limits. For retired seniors the combination of reduced income and increased medical costs means the cost of traditional long-term care insurance can be all or mostly tax deductible.”
